

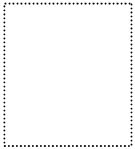

## Transport info, Ray Watson

### France leads the way

It was Paris that pioneered the self-service cycle hire scheme to reduce car traffic in the city – something that has been followed by London and other large cities. Now the French are at it again, this time with environmentally-friendly electric cars.

Like the bikes, the battery-driven Bluecars will be stationed throughout the capital and available for hire for short periods. From the autumn there will be 3000 of them at 1000 locations, each vehicle capable of running 150 miles before re-charging becomes necessary. Speed-wise they will reach up to 80 mph.

The project is aimed at the 58 per cent of Parisians who do not own a car as well as attempting to drive polluting cars off the road.

And the cost? About £40m, but income from drivers will offset part of that. Hirers will have to pay a subscription of about £10 a month, plus £5 for the first half-hour and £3 for the next.

The bike hire scheme has been a big success, despite problems with theft and vandalism. Let's hope the Bluecar scheme is too. That might encourage our mayor Johnson to catch up with his French counterpart.

### Green fuel in the air

There are some welcome moves by the aviation industry to improve its poor reputation as one of the worst -- and fastest-growing -- greenhouse gas delinquents.

Qantas, the Australian airline, aims to slash its carbon emissions by linking with a specialist company in the US that has the technology to produce 'green' jet fuel from waste. The intention is to build a £200 million plant in Australia similar to one planned for London, with BA as a major partner.

European airlines are keen to reduce their reliance on fossil fuels before a new EU scheme comes into force next year under which any airline flying in or out of the EU must cut emissions or pay a penalty.

The aim is for the London plant to turn 500,000 tonnes of household and agriculture waste into 16 million gallons of green jet fuel. This sounds highly laudable, but in fact BA says that this would power only two cent of its Heathrow fleet. However, it is a start.

### Cycling scheme safe?

Bikeability – that is the name of the Government-funded training scheme for young cyclists. Like similar projects, it is in the spotlight when it comes to potential budget cuts. However, it has just produced some good news that might keep the Treasury knifemen at bay.

A survey found that no less than 98 per cent of parents were happy with the scheme and so were 96 per cent of children. Half of the children who had taken the training said they had cycled in the past week against less than a third of those who had not taken the course.

### Campaigns

### Climate and Energy

#### Melting ice to blame for freezing conditions

Scientists have established a link between the cold snowy winters in Britain and melting sea ice in the Arctic, and have warned that long periods of freezing weather are likely to become more frequent in years to come. An analysis of the ice-free regions of the Arctic Ocean has found that higher temperatures there caused by global warming, which have melted the ice flows in the summer months, have paradoxically increased the chance of colder winters.

Some climate scientists believe that the dramatic retreat of the Arctic ice over the past 30 years has begun to change the wind patterns over the northern hemisphere. A study was carried out in 2009, and researchers used computer models to assess the

impact of the disappearing Arctic sea ice, particularly in the area of the Barents and Kara seas north of Scandinavia and Russia.

These facts are particularly useful when discussing the cold weather, and trying to influence local authorities and governments as part of our campaigning, as well as doing our own eco bit.

#### Solar plant will be the world's biggest

A US transnational company has announced that it intends to start constructing one of the world's biggest solar power plants this year. First Solar said the facility based at Ordos in the Inner Mongolia region, would be built in partnership with the state-owned utility company China Guangdong Nuclear Solar Energy Development. Plans for 2 gigawatts (2 billion watts) of generating capacity - the equivalent of two coal-fired power plants - covering 25 square miles, is to be built in stages through to 2020. The first stage is 30 megawatts. When completed it is expected to provide power for three million homes.

#### Wind farm bankruptcy

While it is good news on the US/China solar power front, there is a disappointment with one of the UK's wind farms. 120 jobs have been lost at Skycon's Campbeltown factory in Argyll after the firm went into administration recently. The union Unite has stated that this is a blow to the local economy, and will be negotiating to save the facility.

## Your chance to join airport protest

There is a swelling of resentment in the borough against plans by Biggin Hill Airport drastically to expand its operating hours and number of flights during the Olympic Games. This would entail flights starting early in the morning to nearly midnight, seven days a week including public holidays and with jets carrying up to 75 passengers.

Residents associations, Bromley FoE and other groups have joined together in an organisation called Bromley Residents Against Airport Expansion (BRAAD) to co-ordinate opposition to the scheme. They are ensuring that Bromley councillors, who have to approve the plan, are fully aware of the facts; some believe the full impact of the application has not been given to councillors. Residents too, are disturbed that the council has given insufficient time for consultations and used the Christmas period to reduce that still further.

The consultation period ends February 18<sup>th</sup> and the council will meet after that date to make a decision.

The main fear of Bromley people is that although the application is said to be of a temporary nature during the Games, the airport will use it as a precedent to be made permanent. That would mean the airport would be able to take large-jet flights of

fare-paying passengers – something it has been attempting to obtain for many years.

Some councillors, and Jo Johnson MP for Orpington, have already spoken out, saying that the extra revenue that the council would receive as a result of increased use of the airport is outweighed by the new early-opening and later closing hours, extra noise, air pollution and traffic congestion that would affect residents.

There is also the question of safety at Biggin Hill, given its record of recent accidents, while some also point to the airport's offer to collect a £3 tax from some passengers and pass it to the council, saying the airport has not revealed how much that would yield. They argue that the airport must be desperate to use this ploy to influence councillors.

## Wake up to what's happening at the airport, Ray Watson

Residents can expect a disastrous increase in the size and number of jets taking off and landing if Bromley Council agrees to Biggin Hill Airport's Olympics Proposals.

Operating hours would be extended from very early morning to much later at night. And local residents could say goodbye to quiet weekends and public holidays, when the Airport's hours would be equally long. And more noisy helicopters would disturb local residents both in the early morning and late evening

Aircraft size would increase up to 75-seater jets (scheduled airline size) and not just the smaller business jets seating typically 10-20 passengers. Very recent near-collisions in the airspace above Biggin Hill could become fatal as airspace becomes increasingly congested.

There have already been many crashes, many fatal including that on 30 March 2008 in Farnborough resulting in 5 fatalities, one home demolished and other homes damaged. The aircraft had just taken off from Biggin Hill Airport and was trying urgently to return to that Airport. The crash site was just yards from the 3 Crofton Schools and the Princess Royal University Hospital.

Noise and air pollution would increase dramatically.

And we now learn the Council is expecting further Proposals from the Airport which, according to Mr Marc Hume, Director of Renewal and

Recreation at Bromley Council, would involve "*wider variations*" over and above the Olympics Proposals.

So the Airport's Olympics Proposals are very definitely the thin end of the wedge, and local residents could look forward to the Olympics Proposals – if approved – being made permanent or even extended to, for example, cover full-size commercial fare-paying passenger jets.

If you agree that the lease should not be amended for the Olympics – and hence nor for the "*wider variations*" secretly threatened, tell Council Leader Stephen Carr and also your local Ward Councillor. There's a letter from Cllr Carr on Bromley Council's website.

The consultation period has been extended until Friday 18<sup>th</sup> February. ## “Social Impact” – The view from Down Under, Sheila Brown

*In lieu of a Christmas card, I received the following email from a friend in Australia who has been studying “Social Impact” and is newly converted to thinking we’ve probably accepted for some time. Nonetheless, she has some good ideas, and the zeal of the newly converted, so I thought I would share this with you.*

“As you may or may not know, this year I’ve been studying in the area of **social impact** – looking at solving the world’s problems in more sustainable ways. I’ve been blown away by entrepreneurs and projects that have for example developed nutrient enriched yoghurt to halt malnutrition; introduced smart cards as a banking system in isolated areas of Malawi; produced drugs and medical aids (i.e. hearing aids) at prices the third world can afford; developed and distributed solar energy for those without, and so I could go on .... and the impact on those they serve is literally life changing with implications for economies and well being that simply cannot be measured.

It’s had a big impact on me and ostensibly will help me change my actions for good. So rather than a sending cards this year, I’ve decided to pass on some of my ‘impact’ and ask my friends to consider creating some social impact themselves. If you get the opportunity this year, why not consider:

- Buying yourself either or both a reusable takeaway coffee cup (and remember to take it with you when you are out and about and likely to order take away coffee)

and a stainless steel water bottle to save all those plastic water bottles that add to our waste issues.

- Providing a Loan (not give – loan but you could reinvest) to a microfinance project to lift others out of poverty. *Two Australian websites are mentioned.*
- Buying Fair Trade (and Rainforest Alliance) products - beyond coffee and tea and take more notice of the products you buy to check the company is playing its part to reduce not contribute to global environmental challenges and helping to solve social problems.
- Buying a box of organic vegetables grown close to where you live.
- Watch what you print (remembering one ream of paper = 5.4 kg CO<sub>2</sub> in the atmosphere; 3 sheets of A4 paper = 1 litre of water); buy recycled paper.
- Buying a portion of green energy - most companies are offering this now.
- Plant Trees and buy carbon credits - plant what you can and pay the carbon tax when you next fly - watch your footprint and see how you can reduce business travel.
- Buying a book on Ethical Travel and get planning to go.

## **WDM - Record food prices worsened by banking speculation**

Current soaring food prices are being worsened by record levels of financial speculation, according to a leading UK anti-poverty group. Latest figures from the World Development Movement reveal that hedge funds, investment bankers and pension funds have poured over \$200bn into food markets since the financial crisis, betting on the rising price of food.

This huge wall of speculative money has now reached record levels according to the US commodities regulator. This has caused the market to over-react to shortages in supply or rising demand, pushing food prices ever higher.

This week the UN's food price reached a record high and food riots broke out in Algeria as the impacts begin to be felt around the world. Food prices have now risen above those seen during the global food crisis of 2008 when riots broke around the developing world and over 1 billion went short of food.

Many speculators are simply trying to avoid inflation by throwing money into food markets, betting on long term rising food prices and not reflecting the current state of global food markets. Much of this money has come from efforts to deal with the financial crash like the banking bail out and so-called 'quantitative easing' in Europe and the US.

The World Development Movement are campaigning to stop excessive speculation on basic foods. Regulations are being developed in the US and EU to improve transparency and reduce excessive

speculation, however these are under threat from intense lobbying by the financial services industry.

### **Murray Worthy of the World Development Movement said:**

"Food isn't an asset; it's fundamental to human life. These markets exist to allow people to buy and sell food but are now being used to make huge profits for speculators, at the expense of producers and consumers. Profiteering by financial speculators is worsening this food crisis, further inflating prices both here in the UK and in the developing world."

"These markets need to be brought back under control, limiting excessive speculation by hedge funds and investment bankers, ensuring the markets are fully transparent. Stopping food speculation can help to avoid the levels of food inflation we've seen and help to ensure more people have access to essential food."

In 2009 Skycon acquired the plant from Vestas, another Danish-owned company, heavily involved in the wind turbine manufacturing industry, with a view to expanding the facility to capture and access the growing export market in the Britain and Ireland. This is certainly a case where the government could help fund part of the renewables industry and preserve and create new jobs.

## FoE says – Gov't attempts to keep air pollution information secret

A freedom of information tribunal is being urged by environmental campaigners to reject Government attempts to keep secret sections of ministerial briefing papers on air pollution in London. The Government's appeal against a previous ruling to make the information public was heard in mid-January.

The information could have major implications for Government efforts to prevent the European Union prosecuting the UK for persistently breaching air quality laws. It has been requested by Simon Birkett, who is Founder and Director of Clean Air in London and represented by lawyers from Friends of the Earth's Rights and Justice Centre and barristers Gerry Facenna and Laura Elizabeth John of Monckton Chambers. A separate decision from the EU on its legal action is expected imminently.

In January 2009 Clean Air in London filed a freedom of information request asking for "a copy of any minutes, papers, correspondence or other material relating directly to any meeting that takes places between Lord Hunt (Environment Minister under the previous Labour Government] and Mayor Johnson." The sections of the documents which the Government has yet to release are believed to relate to the western extension of the congestion charging zone and air quality.

Despite two rulings in favour of Mr Birkett (by the Information Commissioner's Office in November 2009 and at an appeal heard by the First-tier Tribunal in May 2010), the

Government has continued to refuse to make the information public.

The Government is appealing for a second time (this time to the Administrative Appeals Chamber of the Upper Tribunal) - arguing that it was entitled to say, for the first time in the First Tier Tribunal, that the information is covered by 'legal advice privilege and litigation privilege'.

### **Simon Birkett, Founder and Director of the Clean Air in London, said:**

"For two years successive Governments have fought to keep information about London's air quality secret - if only they'd put as much effort into meeting pollution laws. The Mayor estimates that the early death of some 4,300 Londoners in 2008 was attributable to long-term exposure to dangerous airborne particles - mainly caused by diesel-powered vehicles. This is a national disgrace. The Government must not be allowed to hide this information - the public interest for publication is overwhelming."

### **Friends of the Earth's Head of Legal Gita Parihar said:**

"The Government's approach to this case makes a mockery of information laws. When the Information Commissioner's Office ruled that the Government's reason for refusing to make the information public wasn't valid, it came up with two completely new reasons for keeping these documents secret. Ministers must deal with freedom of information fairly and openly rather than trying to move the goalposts to protect themselves."

## FoE - Bat for Lashes joins Warm Homes campaign

Natasha Khan of Bat for Lashes (*Ed – no, I don't know either*) has spoken out about living in a cold, slug-infested student house as part of Friends of the Earth's new Warm Homes campaign, launched today. The musician is urging people to email their MP their own stories about living in a cold home at [www.coldtimes.co.uk](http://www.coldtimes.co.uk) and demand Government action to stop draughty British houses making people ill and worsening climate change.

It comes the week before parliamentary discussion of legislation to help insulate the nation's homes begins.

Friends of the Earth is warning the Government's current proposal will do little to keep vulnerable tenants warm without a tough new law to stop landlords letting the coldest properties until they're improved.

Properties rented from a landlord or letting agency are most likely to be the worst insulated and a recent Friends of the Earth survey found half of these tenants were uncomfortably cold in their homes during the big freeze.

Natasha Khan, of Bat for Lashes, said: "We suffered the worst mould you could imagine in my student house. " Over our two-year let it got to the point where you'd have to dodge at least 20 slugs living off the moisture in the carpet - then inhale black mould spores if the steam from the shower got too much. "The cold, draughts and dampness were pretty extreme! " Everyone should get behind Friends of the Earth's campaign to protect

tenants in cold houses - it's time to heat our homes, not the planet."

Friends of the Earth's Warm Homes Campaigner Dave Tams said: "No-one should have to put up with renting a cold, damp home that makes them ill and costs a fortune to heat - £1 in every £4 we spend heating our homes is wasted because of shoddy insulation. " Stopping British houses leaking heat is one of the cheapest and quickest ways to fight dangerous climate change.

"We need a new law making it illegal to let the coldest, health-hazard properties until they're improved to a minimum energy efficiency standard - and greater support for landlords. Tell your MP what it's really like living in a cold home at [www.coldtimes.co.uk](http://www.coldtimes.co.uk) to join the fight for warmer homes and a safer climate."

And in lieu of cards, I'm taking out a microfinance loan that I will reinvest once it's been paid off (giving 10% as a gift to running costs for the project)."

## "This is not OK" – CAAT's new anti-arms trade campaign

**2011 sees Campaign Against Arms Trade's (CAAT) new campaign "This is not OK."** The simple slogan highlights the unethical basis of the Government's enthusiastic support for the arms industry and arms exports.

"This is not OK" is launched on 17 January, the 50th anniversary of President Eisenhower's farewell address, where he warned against the unfettered growth of the military-industrial complex.

In the coming year, CAAT will focus its anti-arms trade message on three separate but interlinked groups and organisations:

The Coalition government, its Ministers, and MPs from the main political parties, in and out of government.

UK Trade & Investment Defence & Security Organisation (UKTI DSO), the government organisation responsible for promoting arms exports and organising and inviting foreign government delegations to UK arms fairs.

Clarion Events, the private company that owns and organises international arms fairs, including DSEi, Defence and Security Equipment International, the biennial London arms fair.

Throughout the year there will be public actions and demonstrations to bring home the message "This is not OK" to the public, to government decision-makers and to DSEi's organisers.

The climax of the campaign will be the DSEi arms fair which takes place in London docklands on 13-16 September 2011.

### **BAN BAE counter-recruitment campaign actions are creating waves in the press!**

BAE Systems is the world's largest arms producer. Its weapons are sold indiscriminately around the world to customers in over 100 countries. BAE's customers have included Israel, Saudi Arabia, Pakistan and Indonesia. BAE trade with what the Foreign Office's Human Rights report classes as "major countries of concern" and have also faced legal proceedings for corruption and bribery. In March 2010 BAE was sentenced to pay a \$400 million criminal fine.

Following a wave of recent actions at graduate recruitment fairs at universities such as Exeter, Bristol, Edinburgh, Warwick, London and Southampton, which saw campaigners staging "die-in" protests in front of BAE's stalls forcefully removed by security staff, Campaign Against the Arms Trade (CAAT) is encouraging students to continue demonstrating everywhere that arms traders attempt to recruit.
