## Transport info, from Ray Watson

### The myth about new jobs

One of the arguments consistently put forward by airports – including our own Biggin Hill – is that expansion will create more jobs. Not always so, according to research by a group opposing growth at Gatwick Airport which has now been passed to the government ministry looking into the future of aviation.

Some of the points made:

- Between 1998 and 2004

despite a 30% rise in air passengers the total employment attributed to airports and airlines actually went down.

- The Airport Operators

Association has forecast that by 2030 an increase of 104 per cent in the number of passengers passing through UK airports will produce a 21% increase in jobs.

- UK residents took 41.5 million more return flights for leisure in 2005 than foreigners came here for leisure. Thus the aviation tourism deficit is costing the UK about 900,000 jobs as a result of people spending their money overseas instead of the UK.

While no one is saying that people should not travel overseas, it is important that the negative cost to the country of aviation should be taken into account when the government acts favourably towards airlines and airports like the current tax breaks they receive. And you can add to that the cost of local environmental and climate change damage.

### Fares unfair

There is enough gloom about as it is, but the annual anger about inflation-

busting rail fare increases does not look as if it will be ending soon. Apart from the fact that the rises may mean that some people will not be able to afford to travel to work and thus may become jobless, passenger groups are beginning to focus on the fact that similarly large rises are scheduled for next year and 2014. They aim to challenge the government's policy of applying increases based on inflation plus 3 per cent.

What is behind the policy is the fact that the government annually pays out £4 billion to subsidise the railways (compared with fares income from passengers of £5.7 billion) and it now wants to get that down by £1 billion.

Another slap in the face for public transport that will drive more people onto the roads, adding to more noise and air pollution.

### Boris bus starts rolling

We all saw the photos of mayor Boris joyfully launching his new bus, a replacement for the bendy bus of which he has been sternly critical. The new double-decker has an open platform for access just like the old Routemaster type. Some have said the new version is nothing more than an expensive election year vanity project to fulfil a pledge the mayor gave before he was elected.

Well, no less than £7m has been spent so far on its development though for that we get another six – and the type is better on carbon emissions.

## Items in brief + Transport info, *continued*

### **One-and-a-half wins**

Bromley FoE recently joined others in objecting to two planning applications – and we came away with one win and one deferred decision.

The successful objection was about a scheme for dozens of heavy lorries to be used to deliver soil and other materials for use at Cherry Lodge Golf course, Biggin Hill. Bromley Council threw out the plan on the basis that there would be major inconvenience in the area, together with excessive noise and pollution.

The second application was for building homes and other buildings on Kent County Cricket Club's ground at Beckenham. Strong opposition was voiced by residents at a council committee hearing, based on the loss of four football pitches and the density of the proposed housing. Councillors also questioned whether the cricket club would benefit financially and deferred a decision until more information was provided.

### **The votes are in...**

Bromley FoE's well-attended annual meeting saw the re-election of Sheila and Ann as joint co-ordinators, and also other office holders. Sheila and Ann expressed their thanks for the help given by a large percentage of members in keeping the group running.

There was a brief discussion on fund-raising, recruiting new members and future campaigning, ideas for which will be taken forward.

But that is still a staggering amount of money for us taxpayers to find, vanity project or not.

### **Real-time help**

Much more practical is a new service from Transport for London where passengers can access live information about bus arrivals at their stop via TfL's website by using a web-enabled phone or a fixed computer. Simply tap in your bus stop number – which can easily be found on the site by entering the route number or the street name -- and up comes live information about arrival times, destination and other information. There is also a text version available at 12p a time.

The system was successfully trialled last year and will now be rolled out to cover all of London's 19,500 bus stops.

### **Noisy progress**

Sometimes technology generates unexpected problems; in this case the electric car. Such vehicles move almost silently and that has resulted in worries for drivers and pedestrians. Apparently, a road safety danger arises if pedestrians cannot hear a vehicle approaching, while drivers, used to listening to engine and gear change noise, are unnerved by the quiet.

What to do? Electric car companies are bringing in sound engineers to create artificial noises while the car is in motion. Everybody happy?

## Campaigns, Energy and Climate info – from Ann Garrett

### Energy and Climate

#### Feed-in Tariff Campaign

Last December a High Court judge ruled in favour of an application by Friends of the Earth and two solar companies - Solarcentury and Homesun - for permission to challenge the Government plans to cut the Feed-in Tariff for solar PV.

The appeal ruling meant that the organisations could submit a legal bid to block the Government's decision. The legal challenge centred around Government plans to slash feed-in tariff subsidies - payments made to households and communities that generate green electricity through solar panels - on any installations completed after December 12<sup>th</sup> 2011.

Andy Atkins FoE Executive Director said: " We're delighted the High Court

has given the go-ahead to our legal challenge - we believe Government plans to abruptly slash solar subsidies are not only unfair, but illegal."

On January 19<sup>th</sup> Government ministers said that if they lost the court case they will fund the higher rate solar subsidy for another three months. Given the gravity of our climate situation this seems very short-sighted to say the least.

#### World's Largest Solar Plant Powers Up

Some mainly good news from Spain - very recently on an empty mountain plateau in Andalusia, the last of 600,000 parabolic mirrors were connected, and Andasol, the world's largest power station became operational.

It's an exciting and shining example of what renewable energy can offer. An ample underground spring system supplies water for the turbines and there are 2,000 hours of sunshine per annum as the main energy source.

However there are problems and these are due again to the possible slashing of Spanish feed-in tariffs. Andasol's director Rainer Kistner says that the business prospects look bleak if this happens, and is stressing the importance of government guarantees for investors. Companies behind Andasol are very nervous at present about future projects as a result of concern about supporting feed-in tariffs. These are essential if renewable energy is to work.

## **A burning issue – Bromley FoE objects to incinerator plans**

Kent Council have applied for planning permission to build a waste-burning incinerator right on the Bromley borough boundary at Orpington Bypass. The application appears to claim that it will be wood-burning to produce some electricity. However, further examination reveals that it will also burn industrial and domestic waste – not so clean, after all, and with possible dangerous emissions. BFoE sent this objection opposing the scheme

I am instructed by Bromley Friends of the Earth to lodge an objection to the proposal to install an incinerator at land between Orpington Bypass and M25, a site that is on the Bromley border.

### **Reasons for the objection:**

1. The site is in the Green belt and is designated an area of outstanding natural beauty. Planning guidance states that there is a presumption against development in the Green Belt unless there are exceptional circumstances, none of which appear to be apparent here. Indeed, the development would turn the area into an industrial zone.
2. Wildlife and ancient woodland would be adversely affected.
3. Emissions from an incinerator burning industrial and domestic waste (and not wood alone) may include noxious particles which might impinge on fruit and vegetable growing at nearby farms and surrounding residential areas. Even burning 'clean' wood such as furniture and fencing (as

stated in the application) risks dangerous emissions caused by such wood having been treated by creosote, stains etc.

4. The frequent use of heavy lorries delivering to the site would add to CO2 emissions at a time when the Government is struggling to meet its legal targets. Further, such lorries would adversely affect residential areas, given that some loads would travel several miles to and from the site.

I would appreciate receiving notice that this message has been received and, eventually, the result of the application.

### **Objection to Queen's Gardens planning application**

The planning application proposes an extension to the Glades commercial area beside the present Leisure Centre with five new restaurants. This would encroach on a green area where the present Italian Gardens are, and which is designated as public open space.

In the Area Action Plan report, the inspector concluded that that if the Glades and Council wanted this facility it should be within the building itself opening on to the Garden or that a single cafe on the terrace or part of the hard standing might be appropriate.

At least one of Bromley FoE's members has registered an objection, thus:

## FoE says - Govt starts new process to cut solar subsidy payments

Government moves to cut solar subsidies by early March - reducing the uncertainty hanging over the solar industry since Ministers attempted to rush through payment cuts in December - have been welcomed by Friends of the Earth.

The solar industry was left reeling - and 30,000 jobs thrown into jeopardy - when the Government announced plans last year to abruptly cut payments for any solar scheme completed after 12 December 2011 - 11 days before an official consultation into the proposals had even closed.

Shortly before Christmas - following a legal challenge by Friends of the Earth and solar firms Solarcentury and HomeSun - the High Court ruled that the Government's plans were illegal, saying Ministers could only alter the payments after going through Parliamentary procedures - allowing industry time to plan for change. Last week the Government challenged the ruling in the Court of Appeal, and a decision is due within the next few weeks.

**LATEST INFO** - The Court of Appeal today (Wednesday 25 January 2012) unanimously rejected Government attempts to overturn last month's High Court ruling that its plans to rush through sudden cuts to solar tariff payments are illegal. The Government is now seeking permission to appeal to the Supreme Court.

Friends of the Earth is also calling on Ministers to boost certainty for solar by using the multi-million pound tax

revenues generated by solar firms - enabling more homes, businesses and communities to switch to clean British energy.

### **Friends of the Earth's Executive Director Andy Atkins said:**

"At last the Government is taking steps to sort out some of the uncertainty that's crippling a thriving UK industry - planned cuts will at last allow solar firms to start planning for the future. Solar payments should be cut in line with falling costs - but by trying to rush through payment before the consultation closed Ministers created a shambolic mess that threatens 30,000 jobs and the future of the industry.

"Ministers must urgently use the millions of pounds in tax that solar firms generate to safeguard this industry and the jobs and businesses it has created. We must do more to protect cash-strapped families from soaring fuel bills - that's why we're campaigning for the Government to fix our broken energy system and enable more people to plug into clean British energy."

### **Notes to editors:**

1. Friends of the Earth's legal challenge to cuts in solar incentives is part of its Final Demand campaign, which calls for energy we can all afford and a public inquiry into the power and influence of the Big Six energy companies.
2. The Government's proposals have already had a devastating impact. Countless planned clean energy

schemes have been abandoned and thousands of jobs are under threat. In December construction firm Carillion warned 4,500 workers their jobs were at risk because of the Government's proposals. 3.. In November last year research by Element Energy, commissioned by Friends of the Earth and the solar industry, showed that the premature cuts could threaten 29,000 jobs and lose the Treasury up to £230 million a year in tax income. It showed that additional costs to lift the cap off the scheme will be more than equalled by extra tax receipts to the exchequer and saving on unemployment benefit that would have been paid to sacked solar fitters.

4. Friends of the Earth is calling on the Government to:

Establish a system which enables feed-in tariff payments to fall from mid February 2012, in line with the falling cost of solar technology, in a way that supports the continued growth of the industry and jobs;

Increase the overall budget for feed-in tariffs using tax revenues generated by jobs created by the scheme - this will enable more households to benefit from solar power.

Exclude housing association, school, council and other community projects from the damaging proposal

to give multi-building projects even lower financial support.

Only require solar projects on homes to install loft and cavity wall insulation where possible - rather than imposing much tougher energy efficiency conditions which would make 9 out of 10 households ineligible for the scheme.

Relax over-strict energy efficiency proposals which will prevent 90 per cent of households applying for solar tariff payments and new measures to boost clean energy for social housing schemes.

## **Objection to Queen's Gardens planning application, *continued***

I wish to object to the above on the grounds that it would take up too much open space which in its present form is greatly used and enjoyed by the public.

The development proposals would not comply with the AAP pledge that no green space would be affected, and there is also the fact that part of the site is in the Bromley Town Centre Conservation Area.

A small cafe for the use of the garden users would be acceptable, but certainly not a large commercial development, which would affect cafe trade in the Bromley North Village area, and spoil the present ambience of Queen's Gardens.

## FoE - Our top 10 wins from 2011

January isn't the happiest of months - what with money being tight and trousers tighter after the December indulgence-fest. So allow us to cheer you up with news about the good things Friends of the Earth got up to in 2011.

### **1. Mega incinerator scrapped**

It would have cost £400 million, burnt valuable materials and belched out climate-changing emissions. But, supporting the local community, we made sure this dirty proposal went up in smoke.

### **2. Slashing councils' CO2 emissions**

Along with our amazing local groups all over the UK, we ran a campaign called Get Serious About CO2. It aimed to get councils cutting CO2 emissions - and it worked. More than 20 now have targets to slash emissions by at least 40% by 2020.

### **3. Warmer rented homes**

An incredible 100,000 people supported our 2-year campaign to make cold homes more energy efficient. We got a law passed so that from 2018 landlords will be fined if they don't improve the coldest rented homes.

### **4. Energy-efficient homes in Northern Ireland**

Friends of the Earth Northern Ireland led a coalition of groups in a campaign to tackle energy-leaking homes. It convinced the Assembly to commit to a major programme of renovating homes so they use less energy.

### **5. A greener bank**

Our campaign with other groups got all 3 major political parties to commit to a Green Investment Bank. The bank will help promote the growth of clean energy and energy-saving technology.

### **6. Fewer plastic bags in Wales**

Our local groups in Wales succeeded in cutting the carriers. Their campaign got the Welsh Assembly to introduce a 5p charge on carrier bags, meaning less waste and more resources.

### **7. Love story in milk**

Two milk bottles met, fell in love and went viral. Nearly a million people watched their touching tale of why recycling is so important. They even won us an award. See what you think of our own dairy-based Romeo and Juliet.

### **8. About 3,000 people laughed at us**

Our comedy gig sold out and brought the house down, with stars including Tim Minchin, Richard Herring and Badly Drawn Boy. The money raised helps fund our fight against climate change.

### **9. Our High Court victory**

We took the Government to court after it slashed payments for solar energy without waiting for its own consultation to end. And we won. The Government is now back in court trying to overturn the decision. Win or lose, David Cameron must support UK solar to help more families free themselves from soaring fuel bills.

## FoE and International Climate - Pushing for a strong, fair agreement after disastrous UN climate talks in Durban

In Durban, countries delayed taking action on climate change and shifted responsibility onto poor countries.

A new treaty will give all countries the same responsibilities for cutting greenhouse gases. The new treaty will not take effect until 2020 - but scientists have warned that we need to cut global emissions well before 2020 to avoid catastrophic climate change.

The targets until 2020 are too low - Current pledges to cut emissions for the next 5-8 years will put us on course for 4-6 degrees of global warming.

### Loopholes remain

The EU can still increase its emissions and meet targets because of carbon accounting loopholes. Even though rich countries are responsible for the majority of emissions, they have benefitted the most from burning fossil fuels and have the resources to make emissions cuts.

This will leave millions at threat from increasingly frequent extreme weather events, and will hit the world's poorest people hardest.

Delaying action will also fail to drive clean growth and create green jobs through investment in renewable energy sources.

The Kyoto Protocol will be discussed next year - what emissions targets will be set and over what period of time.

A Green Climate Fund to help poor countries adapt to climate change has

been established, but it has no money in it.

The Durban Platform for Enhanced Action will be agreed in 2015, and needs to be fair, rules-based and in line with science.

### Friends of the Earth will now be working hard to:

Push rich countries to reduce emissions in line with science, and provide finance and technology for developing countries to act.

Make sure that finance for the green climate fund comes from innovative public sources and not from risky carbon trading schemes.

Promote clean and affordable energy as an alternative to fossil-fuels and a solution to energy poverty.

We have little time left to avoid catastrophic climate change, which makes our campaigning work in this area even more important.

10. A fund to tackle climate change  
We successfully lobbied for a Green Climate Fund, where rich countries provide money for developing countries to tackle climate change. We now need to make sure that developing nations have a say in how the fund is run.

## January Meeting Report – Ray Watson

Bromley has more green open space and recreational areas than any other London borough – 3000 acres, in fact, used as parks, sports grounds, playgrounds, even cycle paths, a BMX track and cemeteries.

How is it all kept under control? That was the question answered by Patrick Philips, Robert Shrembi and Toby Smith from the council's open space unit at BFoE's January meeting.

Much of the physical work is done by an outside contractor who is charged with keeping the areas clean, safe and tidy. Their work is carefully supervised by the council's own staff.

To give one small example of the size of the problem: the council is responsible for no less than one million square metres of grass verges – which, strangely enough, bring more complaints than other potential problem because residents quickly notice an uncut verge outside their home.

The unit looks after 36,000 trees on the borough's streets, works with schools to maintain their sports fields, ensures that 65 playgrounds are safe and litter-free, keeps an untold number of ditches and gulleys free of blockages, controls 300 park events annually --like fetes and pageants -- organises litter-picking in the borough's woodlands, and visits schools to educate pupils about the value of parks and open spaces. Also on the job list: fining owners whose dogs fouled parks.

The overall aim was to make the green space user-friendly and active, and, by maintaining them to a high standard, to make residents respect them more. Vandalism was a costly problem – one person was recently jailed for causing 50 cases of damage totalling £20,000 to park buildings.

However, the introduction in recent years of new programmes to involve residents more in the future of their local park had brought a decline in

vandalism and outbreaks of graffiti. The team said it was all about local empowerment and getting people to take on a little more responsibility.

The creation of the Friends of Parks project had been a great success, resulting in 31,400 hours of free voluntary work, worth £200,000. Once a group was set up, the council helped with some funding and practical help with items like tools, but most decisions about a park's future was left to residents. The 56 friends groups also organise all the gardening work to keep their park tidy. Overall, the groups had brought in £300,000 in grants and donations.

It was pointed out that this was extremely helpful in the light of budget cuts by the council – the unit had suffered redundancies among its staff and grants to some sports clubs using council land and facilities had been reduced.

The aim now was to be innovative to tackle the amount of work that needs to be done. So, said the team, they would be working even more closely with the community – their greatest asset

### From CAAT's Events Diary

#### April 17<sup>th</sup> 2012 Global Day of Action on Military Spending

The UK's military budget is £33 billion a year, yet 56,000 nurses are expected to lose their jobs as cuts are implemented across the public sector. On 17 April, take action in solidarity with peace protesters around the world to say This is NOT OK.

#### May 2<sup>nd</sup> 2012 Challenge arms company BAE at its AGM

In 2011, BAE armoured vehicles made in the UK were deployed in Bahrain against democracy protests. CAAT will be at BAE's AGM in 2012 to make sure the awkward questions get asked.

## WDM - Some success on climate loans!

For the past two years WDM along with the Jubilee Debt Campaign have been campaigning for the UK government to deliver its climate finance to help countries cope with climate change as grants through the UN Adaptation Fund rather than loans through the World Bank.

With the UK's latest announcement of climate finance made in Durban, South Africa, we saw significant movement on this issue. Two major things have happened.

Firstly, the UK government has announced it will put £10 million towards the UN Adaptation Fund. This is the first time that the UK has said it will contribute to the fund, despite being on the fund's board.

Secondly, the UK announced that it would give another £85 million through the World Bank's adaptation fund. Although it's disappointing that the money is going to the World Bank, the good news is that this time the UK has given the majority of its money, £70 million, as grants, not loans.

By finally agreeing to deliver most of its climate funds to help developing countries cope with climate change as grants, rather than loans, the government has finally followed its own stated position. Both coalition parties made pre-election pledges to deliver climate change finance for adaptation as grants and yet failed to deliver on this when it came into power.

WDM and JDC campaigners have done an amazing job in bringing this issue to the attention of politicians and

decision makers in a way that they could not ignore. This success is not only significant in terms of this announcement. One of the reasons we were campaigning against climate loans, even though the funds the UK is offering are not that huge in terms of global climate finance, was to ensure that loans are not seen as an appropriate way for finance for adaptation to be provided in the future. The UK was the first country to give its funds as capital, meaning that the only way it could be passed on was as loans.

However, there is still a long way to go. With climate change more serious than ever, and the outcome of the climate talks in Durban meaning that serious international action has been put firmly on the backburner, adaptation funding is critically needed by communities who are finding their way of life destroyed due to climate related impacts.

Whilst it's good news that the government has finally given some money to the UN Adaptation Fund, it's a tiny amount compared to what is being channelled through the World Bank, and institution that has been repeatedly responsible for reinforcing global power imbalances. And although we are pleased to see UK money being given as grants instead of loans, the struggle for climate justice has a long way to go as long as the World Bank is involved.
