

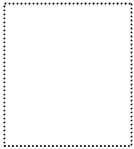

## Report from FoE Local Groups Conference – Dan Sloan

This was held at Nottingham University  
Friday 9th - Sunday 12th September.

As always, the conference was excellent, leaving the delegates feeling inspired and empowered as they left on Sunday evening.

### **Friday - Biomass**

The first Friday afternoon workshop I attended discussed the pros and cons of developing biomass energy generation. The workshop was presented by Brighton Friends of the Earth. Many of the attendees were there because there were proposed biomass power generators proposed in their regions. The big question being, are they sustainable?

The major concern is that rather than use local material to provide the power, timber would be imported from far and wide, this hugely increasing the carbon footprint and completely disregarding the object of small local power generation. The consensus was that fuel for local biomass generation should be sourced within 100 miles of the power station, however, for many of us this is still far to large a radius - 20 miles would seem far more "local".

There is not a specific department in FoE to deal with the Biomass question, so it was agreed that further study should be carried out under the umbrella of the Biofuel team. It is the general policy of FoE not to support large scale schemes.

### **Friday - Will there be any fish left**

The second seminar I attended on Friday afternoon was "Will There be Any Fish Left", presented by David

Levy (Marinet), Stephen Eades (Marinet) and Tim Atkinson (FoE)

This seminar discussed the dreadful condition of our seas and the Food Security Issue (the ability to feed ourselves for 12 months of the year, year on year on our national catch of fish - in fact, currently we only six months of the year, everything else is imported)

Marinet had carried out very valuable research into to numbers of fish in our waters, and produced a very telling graph showing fish decline since the 1880's. Interestingly there were three peaks when fish stocks recovered substantially, these were after the two world wars, and the third in the 1970's (which was thought to be when the fishing of herring was banned, this in turn provided more food for other fish)

One further problem that was highlighted was that fish did not get the chance to grow to full maturity, therefore they ages of fish stocks was becoming younger and younger, so the breeding stocks were very immature - the equivalent of the human race being sustained by ten year old children! Cod mature at 6 years old there are not cod left by the time they attain the age of six.

To start the evening on Friday we had a light hearted question and answer session with the current (Andy Atkins) and four of the former directors of Friends of the Earth, Tom Burke, Jonathon Porritt, Charles Secrett and Tony Juniper. This session was very ably chaired by Elaine Gilligan.

## September meeting report, from Graham Hemington

### **The Big Energy Conversation (Glyn Thomas, FoE Underwood Street)**

BIG because of the involvement of as many people as possible. ENERGY because it's about the forthcoming energy campaign. CONVERSATION because FoE wants to know people's energy priorities and their interest in a clean green energy future.

In a prelude to the forthcoming energy campaign, questions about the choice of energy were first put to 120 FoE groups. Perhaps not surprisingly, renewables and insulation came out top, with nuclear energy attracting little support.

Support for renewables has led to the feed-in tariff scheme which pays people to generate their own green energy but now the government has reduced its subsidy. Glyn quoted an example: a church in Birmingham fitted with solar PV panels paid for by a local organisation and the government subsidy. Then the subsidy was reduced by 50% making the project no longer viable, yet this type of community action is just what the government has been encouraging.

FoE sees its role as persuading the government not to decrease subsidies, not just for community projects but also for small businesses which otherwise would go bankrupt.

FoE will also be petitioning 100,000 people for further evidence of energy preferences. Equally important, to inquire into the intentions of the six big energy companies, e.g. to challenge their proposals to build gas-

fired stations when the supply of gas is decreasing.

Investment in renewables preferred, along with improvement in the insulation of homes (The EU has proposed an energy saving of 20%.)

### **Golf course development opposed – Ray Watson**

Bromley FoE is supporting residents in Biggin Hill and surrounding districts who are opposing a major development at Cherry Lodge golf course. The project calls for major re-shaping of the course itself, together with new buildings and a driving range. However, the main objection is that the work will take up to two years and will involve a fleet of huge lorries delivering soil and other materials.

Residents say there could be up to 70 lorry movements a day, which, they claim would result in air and noise pollution, road damage and add to road congestion because they would have to negotiate steep hills in the area. They also claim that the golf course and adjoining fields are rich in wildlife, including deer and bats, which would be disturbed.

BFoE's submission calls for an environmental impact assessment and demands that, should the scheme be approved by Bromley planners, there should be restrictions on lorry movements.

A decision is likely to be made towards the end of the year.

## Campaigns information – from Ann Garrett

The next Bromley High Street stall is on October 15th from 2.00 - 4.00 pm outside Caffè Nero or in the Mall outside Argos if the weather is bad. There will be petitions and leaflets for the next stage of the Big Energy Conversation. Many thanks to those people who have already agreed to help.

### Results of Big Energy Conversation questionnaires

36 survey forms were completed in total (13 FoE members and 23 members of the public).

1. Most important energy issue facing the UK? - highest results - 11 voted for dependence on imported oil and gas and the impact of our energy system on climate change and 10 for availability and supply of oil and gas. 7 expressed concerns about the safety of nuclear power plants.
2. The UK needs to invest billions to keep lights on and reduce dependency on oil. Where should the money be spent? - highest results - 19 voted for making energy savings in homes, businesses and industry, and 17 for power from the sun, waves and wind.
3. Do you think more green energy should be generated locally? - 33 voted yes. There was 1 no and 2 don't know.

The results of questions 2 and 3 were very positive. Grateful thanks to those who completed the questionnaires and to people who helped on the three stalls (Bromley High Street, Keston Countryside Day and Cudham Fair) to consult the general public. The

process was certainly worthwhile, generating much useful discussion, and creating awareness of ecological demands we are facing.

The work of Glyn Thomas at national FoE is proving valuable in helping organise the materials for this campaign.

### Climate and Energy

#### Planning Bill

Conservationists and green campaigners are urging ministers to rethink planning reforms. They are worried that the new proposals of 'a presumption in favour of sustainable development' in the new National Planning Policy framework, will undermine the government's own creed of 'localism'. The danger would be that major projects such as incinerators and factory farms could easily be approved.

FoE campaigns director Craig Bennett has stated that the proposals threaten the countryside, whilst doing little to curb climate change or carbon emissions. He has emphasised the importance of developing the UK's huge energy potential and in building more fuel efficient and affordable homes.

#### Climate Change and risk of civil wars

Scientists have warned cyclical climate changes double the risk of civil wars with analysis showing that 50 out of 250 conflicts between 1950 and 2004 were triggered by the El Niño cycle.

## Transport information – from Ray Watson

### Stating our case

Bromley FoE has worked with other residents groups in the borough to produce a document that has been sent to the government about Biggin Hill Airport's role in the future of aviation. The submission is part of a broad consultation process that will eventually result in the publication of a White Paper outlining how the government will tackle the problems of handling a growing number of passengers.

The Bromley submission outlines the case against expanding the airport because of its location - the flight path is over thickly-populated suburbs - and also deals with wider questions such as helicopter and other noise, air pollution and traffic congestion. It also suggests that passenger growth could be slowed if huge tax subsidies enjoyed by the industry were cut.

### Redhill row looms

Gatwick Airport environmental group has unleashed a formidable answer to recently-announced expansion plans by nearby Redhill Aerodrome – and it is absolutely nothing to do with Gatwick worrying about a potential rival.

No, the group's main concern is that Redhill's plan to replace its grass strip with a hard runway and take up to 85,000 movements a year, will lead to safety problems, more noise and further expansion due to a potential need for a new control tower and more hangars. The airport denies all this and a battle will be fought, probably at a public inquiry, once the local authority has voted on the Redhill project.

Bromley is not that far from Redhill, so perhaps our council should be taking an interest in the proposal. They might also note that, like nearly all of Biggin Hill Airport, Redhill is in the Green Belt.

### Forgotten fence

Another question for Bromley Council – and we have asked them – concerns the boundary fence at Biggin Hill Airport. This arose when it was revealed that the owners of Lydd Airport in Kent, currently the subject of a public inquiry into its development demands, had not mentioned in its plans the requirement for a 9ft 3in barbed-wire topped security boundary fence for its two-mile perimeter.

Apparently, such a fence is required by European law and by Britain's own National Aviation Security Programme. So, is Biggin Hill subject to these rules as well? We shall see what the council replies.

Meanwhile, at Lydd, the public inquiry may well be delayed while the information on the fence – or lack of it - is collected.

It is also worth noting that Lydd is among Kent airports bidding for additional flights for next year's Olympics.

### Un-fare?

The figures behind the rail fare increases of up to 13 per cent from January are quite staggering. For instance, an annual season ticket from ...

### **Transport info, continued**

Bournemouth to London could rise by £705 to £6,129 – a huge sum that must make our local commuters feel a little better.

Equally, it is not generally appreciated that the train operating companies pass on this extra revenue to the Treasury so it can reduce the amount of subsidy paid by the taxpayer to aid investment in the railways and to keep rail fares down. And how much is that subsidy? No less than a staggering £4.6bn annually.

However, that does, in part, help keep commuters off the roads.

The CFP Reform campaign, and securing its success, is now our major objective over the next twelve months. The campaign is focused on persuading MEPs throughout the EU to use their new voting powers on the CFP to secure real reform, and to persuade our UK Fisheries Minister, Richard Benyon, to do the same.

Therefore lobbying of your MEPs and MPs will remain most important, and I'll be letting you know about the next stage in this lobbying campaign very soon. If *you* have any thoughts or ideas on how or where to focus our campaign in order to achieve its success, please do let me know.

### Local Groups Conference, *cont'd*

Then, later on Friday night we heard how FoE is managing in other parts of the world, with a presentation by Nnimmo Bassey, chair of FoE International, and Jagoda Munic, activist with FoE Croatia. This session was chaired by Vanessa Baird, Editor of the New Internationalist, Jagoda showed us a very amusing slide show of how they carried out their campaigning - some very interesting and bold techniques

We didn't relax until 22.00, by which time most of us were totally exhausted and missed the disco heading straight to bed.

Hot and dry conditions in tropical nations cut food production and lead to outbreaks of violence. Other factors could include rises in unemployment and natural disasters.

The research team at Columbia University, New York are doing important work in monitoring this in relation to progressing understanding of the drivers of human social behaviour.

### Oil surcharges

Green groups are pressuring UN climate negotiators to consider a fuel surcharge on international shipping firms to partly finance a \$100 billion annual pledge to help developing countries meet the challenges of global warming.

Oxfam and the WWF (World Wildlife Fund) are suggesting a levy of \$25 (£15.60) per tonne on fuels that power the global merchant marine, which transports 90 % of the world's trade and contributes an estimated 3 % of the world's greenhouse gas emissions.

Delegates from 193 countries will convene to make decisions in Durban, South Africa for two weeks from November 28th. *Editor's Note* – This meeting is COP17, the United Nations Climate Change Conference, which consists in part of: the 17th Conference of the Parties (COP), and the 7th Conference of the Parties serving as the Meeting of the Parties to the Kyoto Protocol (CMP).

## London Region CND's Nuclear Trains Action Group

### Olympic runners after all?

We reported in the last Nuclear Trains that the authorities had at last admitted that the nuclear trains that run through the Olympic would be "suspended" during the Olympics themselves. Since then, we have seen a letter from the Department of Transport that throws doubt on this.*

Let us review the evidence:

1) On 16th March a spokesperson for Transport for London said that during the Olympics, "Freight traffic will be scheduled so as to release capacity for passenger trains and the Nuclear Waste Trains will be suspended." (Quoted from minutes of meeting of Transport Liaison Consultative Group of Waltham Forest Council.)

2) In its July 21st edition, Hackney Gazette reported that a spokesperson for Direct Rail Services (DRS) had "confirmed" to a Gazette reporter that nuclear trains through the Olympic Site would be "suspended" during the Olympics "following discussions with the ODA and Magnox Ltd" The DRS spokesperson "stressed the decision had nothing to do with terrorist fears... it was to free up more space for passenger trains because of increased demand during the 9-week period of the Olympics and Paralympics."

3) However, a letter from the Department of Transport dated 1st August, sent in response to a Freedom of Information (FOI) request said: "In answer to your specific FOI Question, shipments from Sizewell power station will continue to be allowed to use the

railway line through Stratford during the 2012 Olympics provided they are carried out in full compliance with the regulations covering the transport of radioactive materials. If there were concerns over either the safety or security of these shipments then the powers provided by the relevant regulations would be used to prevent them."

This last seems at first sight a clear contradiction to the previous two statements. But note that it does not actually say that the shipments will continue to use the line through Stratford during the Olympics, only that they will be "allowed" to do so. Moreover the alleged suspension is presented by the spokespeople for both TFL and DRS (however implausibly) as a purely operational matter, which as such would not require government intervention.

As I reported in the last edition of Nuclear Trains, nuclear trains through the Olympic Site that had stopped running since April 19th resumed on 12th August. They have continued running since then at the rate of two trains a week, usually carrying two flasks of nuclear fuel rods each. This has prompted NTAG to switch its next planned stall on September 24th from Wembley Central to Stratford.

At this stall we will hand out leaflets publicising this resumption, saying that though we welcome their suspension during the Games, continuing to run them before the Games will still provide a possible terrorist target - a successful attack in the vicinity of the Park would ...

... require mass evacuation for a considerable period and almost certainly make it impossible to use the Olympic Park for the Games in 2012.

On September 13<sup>th</sup>, the opening day of the Westfield Shopping City at Stratford, we leafleted the crowds coming out with leaflets asking:

"Did you know that Direct Rail Services who run nuclear trains through Stratford have agreed to suspend them during the Olympics and Paralympics next year?"

and making the point:

"If these trains are far too dangerous to be allowed to go anywhere near athletes and spectators attending the Games, then they are far too dangerous to be allowed to go anywhere near Westfield shoppers or people living in Stratford."

## What FoE and FoE Europe had to say

### **FoE says - More than 80% of people think slop buckets are trouble-free**

More than 80% of people with food waste collections say they're no trouble and should be provided by all councils, according to new research launched by Friends of the Earth today, rubbishing claims by a Government Minister that householders don't want to use slop buckets.

The new research, 'Storm in a Slop Bucket', reveals that the overwhelming majority of those who have food waste bins at home don't have a problem with them. 82% say they're not a nuisance compared to 56% of people who don't have one, strongly suggesting that the actual experience of separating food waste dispels concerns.

Only 143 of England's 322 local authorities currently collect food waste and just a handful more are planning to do so, leaving England lagging behind Wales, where all 22 local authorities provide food waste collections.

The research also found that more than 80% of people have become concerned about the increasing cost of food in the last two years.

### **Friends of the Earth's Waste Campaigner Julian Kirby said:**

"It's a load of rubbish that food waste collections are smelly and unpopular - most people think they're hassle-free and want all councils to provide them." Weekly food waste pick-ups can help us cut down the amount of food we

throw away, which is good news for our bank balances as well as the environment.

"As food prices rise it's more important than ever that we cut waste and recycle the scraps that can't be eaten - and we can make genuinely renewable energy from what's left over. " David Cameron must build on the success and popularity of recycling by setting a goal to halve the rubbish England throws away by the end of the decade."

### **FoE says - Council carbon cuts due to recession not green action**

The fall in carbon dioxide emissions in local council areas announced recently is mainly due to the recession, not green policies - which means emissions will rise when the economy picks up and local areas are missing out on green job and business opportunities, said Friends of the Earth.

The environmental campaigning charity also welcomed yesterday's Government announcement that it will ask the independent Committee on Climate Change to advise on local authorities' role in tackling emissions as a step in the right direction - but said this must result in local councils doing their share to meet UK targets for tackling climate change.

Government estimates for 2009, published today, show carbon ...

## What FoE and FoE Europe had to say, *continued*

### **FoE Europe says Europe's resource reduction plan doesn't measure up**

A plan unveiled to tackle Europe's dependency on imported resources does not go far enough to end the region's over-consumption of the world's water, land and other materials.

The Roadmap to a Resource Efficient Europe acknowledges that major increases in Europe's resource efficiency are needed to compensate for growing competition for the world's resources. However, it is vague about how this transformation is going to happen, leaving most of the substance for future policy processes.

Ariadna Rodrigo, resource use campaigner at Friends of the Earth Europe, said: "Europe's resource consumption is amongst the highest in the world. Our dependence on imports from the rest of the world is expensive for companies and consumers and is harming the environment and communities in the global south. Europe urgently needs to cut out waste and focus on quality of life, not excessive consumption - today's roadmap doesn't measure up to the task at hand."

Friends of the Earth Europe is pushing for Europe to measure the entirety of its global land, water, carbon and material footprints, and then reduce them. The European Commission's plan to develop indicators for these four areas is welcomed, but there must be no further delay in deciding precise indicators.

The Roadmap contains some welcome commitments that FoE Europe now wants to see implemented:

- Europe needs to move towards an economy based on re-use and recycling, with residual waste close to zero, and focus funding on recycling and other approaches which minimise waste;
- Further measures on resource use of products, including on the broader environmental footprint of products, though these proposals are currently vague.

### **FoE on Council Carbon Cuts, *cont'd***

... emissions assigned to local authority areas have fallen by almost 13 per cent since 2005. Councils have influence over about 80 per cent of UK emissions.

### **FoE's senior parliamentary campaigner, Liz Hutchins, said:**

"Disappointingly, the sharp fall in emissions councils have influence over is largely due to the recession - not green policies which could boost jobs and businesses at the same time. Councils have a vital role to play in meeting UK climate targets - but unfortunately most aren't doing enough.

"Independent advice from the Committee on Climate Change on council action to slash emissions is a significant step forward - but this must lead to councils playing their part in meeting UK climate targets."

Thousands of weapons buyers and sellers came together in London's East End for a massive arms industry jamboree at DSEi, the world's largest arms fair.

### **They tried to keep it quiet, but campaigning exposed the event for what it was.**

CAAT put pressure on the UK government to publish its invite list, revealing that 14 authoritarian regimes had been invited to shop for weapons – including countries that the government itself has said have “the most serious and wide-ranging human rights concerns”

We helped Caroline Lucas expose the companies illegally promoting banned cluster munitions – showing how the arms fair organisers can't, or won't, control the deals that might be done at the fair.
